TIERRA DEL SOL PRIVACY POLICY

Updated: October 22, 2019

This Privacy Policy applies to this website located at https://www.tierradelsol.org ("Website") which is owned and operated by Tierra del Sol Foundation ("https://www.tierradelsol.org", "we", "us", or "our"). This Privacy Policy describes what information is collected by us from any user of the Website (collectively or individually "user(s)," "yourself," or "you"), as well as our use and disclosure of that information. We treat your privacy seriously.

Please read this Privacy Policy carefully, as it governs your use of the Website. Your use of our Website indicates to us that you have read and accepted our privacy practices, as outlined in this Privacy Policy.

We use your data to provide and improve the Website. By using the Website, you agree to the collection and use of information in accordance with this policy.

DFFINITIONS

Website

Website is https://www.tierradelsol.org and any network operated by us.

Personal Data

Personal Data means data about a living individual who can be identified from those data (or from those and other information either in our possession or likely to come into our possession).

Usage Data

Usage Data is data collected automatically either generated by the use of the Website or from the Website infrastructure itself (for example, the duration of a page visit).

Cookies

Cookies are small pieces of data stored on your device (computer or mobile device).

Data Controller

Data Controller means the natural or legal person who (either alone or jointly or in common with other persons) determines the purposes for which and the manner in which any personal information are, or are to be, processed.

Data Processors (or Website Providers)

Data Processor (or Website Provider) means any natural or legal person who processes the data on behalf of the Data Controller.

We may use the websites of various Website Providers in order to process your data more effectively. For the purpose of this Privacy Policy, we are a Data Processor of your Personal Data.

Data Subject (or User)

Data Subject is any living individual who is using our Website and is the subject of Personal Data.

INFORMATION COLLECTION AND USE

We collect several different types of information for various purposes to provide and improve our Website to you (subject to your consent when required by applicable laws).

TYPES OF DATA COLLECTED

PERSONAL DATA

While using our Website, we may collect certain personally identifiable information that can be used to contact or identify you ("Personal Data"). Personally identifiable information we collect includes:

- IP Address
- Cookies
- Name, address, phone number or photograph
- Usage Data
- * and other similar information.

BROWSER, NETWORK, AND DEVICE INFORMATION

We also collect information when you use our Websites relating to your web site browser, network, device, and other similar information. This information is collected to ensure you have a consistent experience when using our Websites, to ensure our content is displayed properly, and to improve the overall quality of our Websites. If we serve ads, this information is also used

to ensure advertisements are properly displayed to you. Personal information collected related to your browser, network, and device information, includes:

- Device ID
- Operating System
- Query Terms
- Browser Type
- Network Type
- * and other similar information

REGISTRATION

The website is free to view without registering. However, if you decide to use Contact Us, you will be asked for certain personal information. Additionally, you may register to participate with certain activities we are associated with and at the time you register you may fill out a written registration form requesting the below information. This personal information is necessary to manage your account, to provide our Websites, and for other customer management or internal account purposes. In this case, the personally identifiable information may include, but is not limited to:

- Full Name
- Phone Number
- Address
- * and other similar information

USAGE DATA

We may also collect information how the Website is accessed and used ("Usage Data"). This Usage Data may include information such as your computer's Internet Protocol address (e.g. IP address), browser type, browser version, the pages of our Website that you visit, the time and date of your visit, the time spent on those pages, unique device identifiers and other diagnostic data.

TRACKING COOKIES DATA

We use cookies and similar tracking technologies to track the activity on our Website and hold certain information.

Cookies are files with small amount of data which may include an anonymous unique identifier. Cookies are sent to your browser from a website and stored on your device. Tracking technologies also used are beacons, tags, and scripts to collect and track information and to improve and analyze our Website.

You can instruct your browser to refuse all cookies or to indicate when a cookie is being sent. However, if you do not accept cookies, you may not be able to use some portions of our Website.

Examples of Cookies we use:

- Session Cookies. We use Session Cookies to operate our Website.
- Preference Cookies. We use Preference Cookies to remember your preferences and various settings.
- Advertising Cookies. Advertising Cookies are used to serve you with advertisements that may be relevant to you and your interests.

We use the collected data for various purposes:

- To provide and maintain our Website
- To notify you about changes to our Website
- To allow you to participate in interactive features of our Website when you choose to do so
- To provide customer support
- To gather analysis or valuable information so that we can improve our Website
- To monitor the usage of our Website
- To detect and prevent fraud
- To detect, prevent and address technical issues
- To pay or to receive payments related to our Website

LEGAL BASIS FOR PROCESSING PERSONAL DATA UNDER GENERAL DATA PROTECTION REGULATION (GDPR)

If you are from the European Economic Area (EEA), our legal basis for collecting and using the personal information described in this Privacy Policy depends on the Personal Data we collect and the specific context in which we collect it.

We may process your Personal Data because:

- We need to perform a contract with you
- You have given us permission to do so
- The processing is in our legitimate interests and it's not overridden by your rights
- For payment processing purposes
- To comply with the law

RETENTION OF DATA

We will retain your Personal Data only for as long as is necessary for the purposes set out in this Privacy Policy. We will retain and use your Personal Data to the extent necessary to comply

with our legal obligations (for example, if we are required to retain your data to comply with applicable laws), resolve disputes, and enforce our legal agreements and policies.

We will also retain Usage Data for internal analysis purposes. Usage Data is generally retained for a shorter period of time, except when this data is used to strengthen the security or to improve the functionality of our Website, or we are legally obligated to retain this data for longer time periods.

TRANSFER OF DATA

Your information, including Personal Data, may be transferred to — and maintained on — computers located outside of your state, province, country or other governmental jurisdiction where the data protection laws may differ than those from your jurisdiction.

If you are located outside United States and choose to provide information to us, please note that we transfer the data, including Personal Data, to United States and process it there.

Your consent to this Privacy Policy followed by your submission of such information represents your agreement to that transfer.

We will take all steps reasonably necessary to ensure that your data is treated securely and in accordance with this Privacy Policy and no transfer of your Personal Data will take place to an organization or a country unless there are adequate controls in place including the security of your data and other personal information.

DISCLOSURE OF DATA

GENERALLY

We internally share your personal information as necessary to provide our Websites, and for the purposes set forth in this Privacy Policy. We do not share your personal information, including usage data, and other information we have collected about you in accordance with this Privacy Policy, with third parties to allow third parties to deliver advertising, marketing, or other content through the Websites for commercial purposes. We may share aggregate data for marketing purposes.

BUSINESS TRANSACTION

If we are involved in a merger, acquisition or asset sale, your Personal Data may be transferred. We will provide notice before your Personal Data is transferred and becomes subject to a different Privacy Policy.

DISCLOSURE FOR LAW ENFORCEMENT

Under certain circumstances, we may be required to disclose your Personal Data if required to do so by law, or in response to valid requests by public authorities (e.g. a court or a government agency).

LEGAL REQUIREMENTS

We may disclose your Personal Data in the good faith belief that such action is necessary to:

- To comply with a legal obligation
- To protect and defend the our rights or property
- To prevent or investigate possible wrongdoing in connection with the Website (e.g. to prevent or investigate fraud)
- To protect the personal safety of users of the Website or the public
- To protect against legal liability

SECURITY OF DATA

The security of your data is important to us, but remember that no method of transmission over the Internet, or method of electronic storage is 100% secure. While we strive to use commercially acceptable means to protect your Personal Data, we cannot guarantee its absolute security.

"DO NOT TRACK" SIGNALS

We do not support Do Not Track ("DNT"). Do Not Track is a preference you can set in your web browser to inform websites that you do not want to be tracked.

You can enable or disable Do Not Track by visiting the Preferences or Settings page of your web browser.

YOUR DATA PROTECTION RIGHTS UNDER GENERAL DATA PROTECTION REGULATION (GDPR)

If you are a resident of the European Economic Area (EEA), you have certain data protection rights. We aim to take reasonable steps to allow you to correct, amend, delete, or limit the use of your Personal Data.

- The right to withdraw consent. You also have the right to withdraw your consent at any time where we relied on your consent to process your personal information.

Please note that we may ask you to verify your identity before responding to such requests.

You have the right to complain to a Data Protection Authority about our collection and use of your Personal Data. For more information, please contact your local data protection authority in the European Economic Area (EEA).

WEBSITE PROVIDERS

We may employ trusted third party companies and individuals who are compliant with GDPR to facilitate our Website ("Website Providers"), to provide the Website on our behalf, to perform Website-related websites, or to assist us in analyzing how our Website is used.

These third parties have access to your Personal Data only to perform these tasks on our behalf and are obligated not to disclose or use it for any other purpose.

ANALYTICS

We may use third-party Website Providers to monitor and analyze the use of our Website.

Google Analytics

Google Analytics is a web analytics website offered by Google that tracks and reports website traffic. Google uses the data collected to track and monitor the use of our Website. This data is shared with other Google websites. Google may use the collected data to contextualize and personalize the ads of its own advertising network.

You can opt-out of having made your activity on the Website available to Google Analytics by installing the Google Analytics opt-out browser add-on. The add-on prevents the Google Analytics JavaScript (ga.js, analytics.js, and dc.js) from sharing information with Google Analytics about visits activity.
