Remembering Shirley Gydow



Karen and Shirley Sydow – the early years



In May of 2021, Tierra and others said farewell to Shirley Sydow, a longtime Tierra parent whose devotion to her daughter Karen, inspired thirty years of remarkable volunteer service and the love of so many whose lives she touched.


As the parent of a daughter born with cerebral palsy and autism in 1960, Shirley experienced firsthand the challenges and isolation of raising a child with developmental disabilities. "There were no services back then to help Karen or support her," shared Shirley in a 2017 interview. "Tierra became her life and we were happy for her to have a place to go; a place that provided the

best environment for each individual."

Her role as a tiger mom and passion to get involved at an organization that helped her

daughter was immediate and contagious. For 15 years she led a parent service group and organized annual spaghetti dinners that raised money for a new pool heater and air conditioners for the classrooms among other on-going improvements for clients and staff. Although soft-spoken, Shirley was never intimidated to address a room full of people, especially when it came to advocacy for those with disabilities. As a highly skilled quilter, she hand-crafted beautiful quilts that were donated to Tierra's fall festivals, galas, and golf tournament auctions. In 1998, she joined Tierra's Board of Directors and continued inspiring parents to get involved through advocacy, volunteerism, and fundraising.

Having worked closely with Shirley for many years, Steve Miller (Tierra's past CEO) recalls, "When I think of Shirley, I'm reminded that love is an action word. She poured her love for Karen into devoted service to every school and organization that served her daughter. Her service to Tierra as leader of our parent service group and on our board, helped us establish a culture and set of values that honor the uniqueness and basic goodness of each person and family it serves. What a Legacy!"

Several months after we said goodbye to Shirley, Karen passed away. In honor of Karen's life, Shirley's son, Erik Sydow, wrote a loving, unconventional obituary about his sister that went viral after LA Times journalist, Daniel Miller, retweeted it and wrote an article. The story touched hundreds of thousands of people and resulted in McDonalds and Coco-Cola hosting multiple fundraisers in honor of Karen, designating a percentage of the funds to Tierra's programs and services. It's moments like these when the universe reminds us we are not alone and the story of our lives is more impactful than we realize.
